

## **The Hidden Agenda**

### **America Controlled by an Elite Central Government**

#### **Power and Money Drives the Open Border**

It should be a no brainer that the borders should be closed to stop the drugs and uncontrolled movement of millions of illegal migrants into the United States.

But it has not happened. Why? It is all about power and a means of reforming the nation from a democratic republic to a Stalinist form of government. There are powerful forces benefiting from this uncontrolled migration. Billions of dollars and control are at stake.

Certain politicians are relying on funds, provided by open border advocates, to develop an uneducated voting block to stay in power, making over the nation into a divided class of subservient voters and an elitist controlling central government.

**Key to remaining in power** is the financial contributions or support from individuals or groups who have an interest in more liberal immigration policies. For example:

Donors with business interests: Some businesses benefit from the availability of immigrant labor, especially in industries that rely on low-skilled or seasonal workers. These businesses or industry associations provide financial support to politicians who support open borders or more favorable immigration policies.

Advocacy organizations: Non-profit organizations or advocacy groups that promote immigrant rights or more inclusive immigration policies financially support politicians aligned with their goals. These organizations often rely on donations from individuals, foundations, or other sources to fund their activities, including political contributions.

Political fundraising: Politicians supporting open borders receive financial contributions from individuals or groups who align with their ideological or political positions. These contributions can come from grassroots supporters or even high-net-worth individuals who prioritize immigration issues.

**In sectors with a high demand for low-skilled labor**, employers benefit from the availability of undocumented workers who are often willing to accept lower wages and work in challenging conditions.

Certain industries such as agriculture, construction, hospitality, and domestic work rely on undocumented labor due to the demand for cheap and flexible workforce.

However, there are certain groups that **indirectly benefit** from the presence of undocumented immigrants include:

Human traffickers and smugglers: These criminal networks profit from the desperation of individuals seeking to migrate illegally, often charging large sums of money to facilitate their entry into a country.

Informal economy: Undocumented immigrants contribute to the informal economy by working in cash-based jobs, which can provide them with a means of survival and support certain local businesses.

Consumers: Some argue that consumers benefit indirectly from low-cost goods and services resulting from the lower production costs associated with undocumented labor.

**Public employee unions**, like any other interest group, advocate for more inclusive immigration policies:

Expanding union membership: Public employee unions see immigration as an opportunity to increase their membership base. By advocating for the rights and inclusion of immigrant workers, they aim to bring more workers into the union fold, which can **enhance their bargaining power and influence**.

On top of the list is the teacher's union. In California, the primary funding mechanism for school districts is the Local Control Funding Formula (LCFF), which was implemented in 2013. Under the LCFF, funding is allocated based on a district's **average daily attendance** (ADA), which represents the number of students attending school each day. The LCFF establishes a base funding amount per student, called the "base grant," which serves as a starting point for funding calculations.

In addition to the base grant, the LCFF provides supplemental and concentration grants to districts with higher percentages of **low-income students, English learners**, and foster youth. These additional grants aim to address the additional educational needs of these student populations. The exact amounts of the supplemental and concentration grants vary depending on the specific student demographics within each district.

It is important to note that the exact dollar amount per student can fluctuate annually based on the state's budget allocations and any changes made to the funding formulas. As of September 2021, the estimated average funding per student under the LCFF was around \$11,000 to \$12,000 per year. **The inclusion of illegal students represents billions of dollars to the school districts.**

**Performance is not a criteria, the more children the more money.**

There are several other unions and labor organizations in the United States that have expressed support for more open immigration policies and the concept of open borders.

Service Employees International Union (SEIU): SEIU is one of the largest labor unions in the United States, representing a diverse range of workers in various sectors, including healthcare, janitorial services, and public services. The union has been vocal

in supporting immigration reform and advocating for a path to citizenship for undocumented immigrants.

United Farm Workers (UFW): UFW is a labor union that primarily represents agricultural workers. It has a history of advocating for the rights of immigrant farmworkers and supporting comprehensive immigration reform. The union has called for policies that provide a pathway to legal status and protection for undocumented agricultural workers.

American Federation of Labor and Congress of Industrial Organizations (AFL-CIO): AFL-CIO is a federation of labor unions representing a wide array of industries and workers. While the federation does not have an official stance on open borders, it has supported comprehensive immigration reform that includes a pathway to citizenship and the protection of workers' rights, regardless of immigration status.

United Food and Commercial Workers (UFCW): UFCW is a union representing workers in the retail, food processing, and meatpacking industries, among others. The union has voiced support for comprehensive immigration reform that includes a pathway to citizenship and workplace protections for immigrant workers.

National Nurses United (NNU): NNU is the largest union of registered nurses in the United States. The union has expressed support for immigration policies that promote the health and well-being of immigrant communities, including providing a path to citizenship for undocumented immigrants and ensuring access to healthcare for all.

**Illegal immigration is not beneficial for the individuals involved or for society as a whole. So who are the losers? The Citizen poor and the middle class!**
